## 4. FIRST AID MEASURES

### 4.1 Description of First Aid Measures:

<b>Eye</b>	Immediately flush eyes with large quantities of water, while holding the eyelids apart. Get medical attention if irritation persists.
<b>Skin</b>	Remove contaminated clothing. Wash skin thoroughly with soap and water. If irritation or symptoms develops, get medical attention. Launder clothing before re-use. Treat for frostbite if necessary.
<b>Inhalation</b>	Immediately remove victim to fresh air. If breathing is difficult have qualified personnel administer oxygen. If breathing has stopped, administer artificial respiration.
<b>Ingestion</b>	Ingestion is an unlikely route of exposure for aerosol products. If ingestion occurs, do NOT induce vomiting. Rinse mouth immediately and drink plenty of water. Immediately call local poison control center or go to an emergency department. Never give anything by mouth to an unconscious or drowsy person. If vomiting occurs spontaneously, keep head below hips to prevent aspiration into the lungs.

### 4.2 Most Important Symptoms and Effects, Both Acute and Delayed:

This product is an aerosol product. Spraying into the eyes may cause eye irritation or injury. May cause frostbite by skin contact. May be harmful if inhaled, causing dizziness, drowsiness, loss of consciousness, irregular heartbeat, and death. Aspiration into lungs during swallowing or vomiting may cause fatal or harmful lung damage.

### 4.3 Indication of Any Immediate Medical Attention and Special Treatment Needed:

Medical attention may be required for eye exposure or inhalation. Get immediate medical attention for ingestion.

## 5. FIRE-FIGHTING MEASURES

**5.1 Extinguishing Media:** Use carbon dioxide, foam or dry chemical extinguishing powder. Do not use water.





### 5.2 Special Hazards Arising from the Substance or Mixture:

This product is an extremely flammable aerosol. Vapors are heavier than air and may travel along surfaces to remote ignition sources and flash back. Contents under pressure. Keep away from ignition sources and open flames. Containers may rupture or explode under fire conditions. Decomposition may release oxides of carbon.

### 5.3 Advice for Fire-Fighters:

<b>Fire Fighting Procedures:</b>	Use water to cool exposed containers and structures and disperse flammable vapors.
