

PATIENT INFORMED CONSENT FORM

Dentsply Sirona Pty Ltd ABN 87 111 950 602 having a place of business at 11-21 Gilby Rd, Mount Waverley VIC 3149 (hereinafter “**DENTSPLY SIRONA**”) desire to obtain information contained in dental patient cases in order to be able to use such information worldwide for marketing and advertising, education, case study information for commercial and/or educational purposes, and other legitimate purposes, externally as well as internally.

Dr [---] (“Dentist”) has declared [himself/herself] willing to provide DENTSPLY SIRONA with such patient case material, including but not limited to photos, x-rays, illustrations, texts, information on laboratory procedures and other written or visual documentation, on the assumption that [his/her] patients give their written individual, voluntary approval thereof.

Personal information which will NOT be handed over to Dentsply Sirona are your name, address, email address, phone number and portrait photographs.

You as a patient are hereby being asked to provide your consent so that material from your patient case may be shared with DENTSPLY SIRONA and processed as described herein.

Before you decide if you want to provide your consent it is important for you to understand why DENTSPLY SIRONA collects the material and how your information will be used. Please take time to read the following information carefully before providing your consent. Even if you decide not to provide your consent, you will not be disadvantaged in any way.

What you consent to and how we handle your personal data

If you provide your consent, your Dentist will collect personal data including sensitive personal data (such as health conditions) from your dental patient case to be able to create a case report. The case report will be shared with DENTSPLY SIRONA for the purposes described below. The personal data that is collected includes but is not limited to, photos taken before, during and after treatment, X-rays, illustrations, texts, information on laboratory procedures and other written, oral or visual documentation (all the foregoing your “personal data”). DENTSPLY SIRONA is responsible as a data controller for the processing of your personal data which is collected on behalf of and shared with DENTSPLY SIRONA by your Dentist as set forth above.

The purpose of processing your personal data

The purpose of collecting and managing your personal data is for DENTSPLY SIRONA to use the information in the case reports to: i) market DENTSPLY SIRONA’s products and services in

brochures, printed press, Internet, at exhibitions, or through any other media; ii) provide education and training to others in the field of dentistry; (iii) use the case report in scientific or other journals; and (iv) to conduct market related research and development of DENTSPLY SIRONA's products and services.

Legal basis for the processing

Australian privacy law requires us to have a legal basis before processing any personal data about you. The legal basis for us processing your personal data for the above purposes will be because you have provided your consent.

How we will handle your personal data

Since DENTSPLY SIRONA is part of a multinational group it may share your personal data with other companies within its group, its service providers or its contractors, who will use your personal data only for the purposes described herein. Such group companies, service providers and contractors may be based outside of the Australian Economic Area. DENTSPLY SIRONA shall however ensure that such group parties or third parties treat the personal data with adequate safety measures in place. Please also note that your personal data might be used by your Dentist in his/her presentations.

DENTSPLY SIRONA may transfer your personal data to countries outside Australia for the purposes mentioned above. The laws in certain countries may not provide the same level of data protection as the laws in Australia when it comes to handling of personal data. However, we will put appropriate, legally required, safeguards in place to help protect your personal data. For more information about those safeguards, please get in touch using the contact information set out in the paragraphs below.

How long we will retain your personal data

Your personal data will not be retained longer than is necessary for the purpose of the processing as described above. Once the marketing material/case report is fully published, we will delete any additional personal data stored about you that is not needed for maintaining of the publication /marketing material or for fulfilling the purposes described above.

Your rights

You have the right to at any point in time withdraw your consent without prejudice to the legality of the processing on the basis of the consent prior to it was withdrawn. You have the right to request access to information about any personal data that DENTSPLY SIRONA may hold about you. You also have the right to request that any inaccuracies in your personal data be corrected, to restrict processing of your personal data, and to request for erasure of your personal data.
